### **Course Description:**

Grading: Papers will be graded using several criteria. Style, originality, knowledge of the subject matter and the relationship to the criminal justice system will be the major areas of consideration. Grammar, format errors, or technical errors will result in points being deducted.

## **Style Requirement:**

Students will be required to use the "author, year" or "in-text" citation format. This is known as the American Psychological Association (APA format) and is the standard format used by the Chaminade University of Honolulu, Criminal Justice program. Papers must be typed, double-spaced with a 1 1/2" left margin, and 1" right, top and bottom margins. In an effort to conserve the world's resources, you will be required to turn in your paper on a 3.5-inch floppy disk, which I will provide, or you may e-mail me your paper. You may turn in a hard copy of your paper ifyou so desire, but you will still be required to turn in your paper on the 3.5-inch diskette as well.
