CJ 223² Introduction to Law

Instructor: Dennis Klein, Esq., 955-1500 (days)

COURSE DESCRIPTION: Nature and origins of criminal law, general principles of criminal liability and defenses, and the elements of various crimes such as persons, property, habitation and public order and morals.

ABOUT THE INSTRUCTOR: Mr. Klein has over twenty years' experience in the practice of law, including working as an Assistant District Attorney in New York City, a Courts Specialist for the Colorado Division of Criminal Justice, a Deputy District Attorney in Colorado and as a criminal defense attorney in Hawaii. Mr. Klein is a member of the bars of New York, Colorado and Hawaii, and has taught legal courses for several years.

COURSE OBJECTIVES: This is a general survey of various areas of law to introduce the students to legal systems and the practical application of the law to factual situations in their personal and professional lives. An emphasis will be placed upon criminal law and criminal procedure. Through textbook readings, real life examples, exams, individual and team projects and assignments, and classroom discussions, the student will develop an understanding of our American legal system.

TEXTBOOK: *Introduction to Law*, Walston-Dunham, West Publishing Co., 3rd edition, 1999.

GRADING: Tests: 80% of the final grade. Note: there are a total of ten tests of equal weight; the lowest test grade will be dropped.

Participation: 20% of the final grade. Participation grade includes attendance/absences, tardiness, preparedness for class, promptness and quality of projects and assignments, participation in class, disruption of class (e.g., cell phones, talking, etc.) inattention, and points will be deducted for such behavior upon notice to the student for each deduction and the reason therefor, as will be discussed in class. All tests, projects and assignments are due when they are due. The ability to meet deadlines is an important job skill. No make-ups are allowed for any work, except that when students know in advance that they will be absent for a reason considered valid in the discretion of the instructor, a make-up test might be allowed as determined by the instructor.
