- Class Participation:** Each student is expected to participate during class/group discussions and be respectful of opinions that others may have.
- Assignments:** Application is key to comprehension. Be prepared. The purpose of assignments is to demonstrate understanding, writing skills, and provoke thought. All assignments are to be typed, using 12 point font, one inch margins, and be double spaced. Please have your name in the upper left hand corner along with the date the assignment was due. Late assignments will be accepted on a case by case basis and must be discussed with the instructor prior to the due date.
- Articles:** Each week, you will submit two articles that contain the summary of the article and your reaction/response to them. They must relate to the topic of the week and must be within the past two years. The length of your reaction paper varies.
- Case Briefs:** Case briefs will be assigned each week and will contain the following: name of case, citation, criminal charge, facts, procedural history, legal issue, court ruling, and final disposition of the case.

**Research Paper:** The topic of your paper will reflect the class and must be approved by the instructor at the onset of class. The format of your paper must be APA with a minimum five pages. There is no maximum. You must use a minimum of three resources. You will be graded on knowledge of the topic, analysis, resources used, presentation, and the ability to abide by the stated structure. Resources will be reviewed to determine reliability and credibility. Late papers will be accepted on a case by case basis and must be discussed with the instructor prior to the due date.
