**Objective:** The study of the American legal system and various subject areas of law. Areas include:

criminal law, criminal procedure, contracts, property, torts, business and family law. This

course provides competencies to meet the program outcome to allow students to

demonstrate an understanding of learning the basic rights guaranteed to each individual

by both state and federal constitutions and laws. (Catalog Description).

**Grading:** Grades will be based on the following:

**Attendance:** Attendance is mandatory, essential, and will fall within school guidelines -- meaning it will and can affect your final grade. If you do not attend for a two week period, which means you missed 20% of class, you will likely fail the class or be asked to withdraw. Repeated tardies will also result in a reduced grade or overall failure (two tardies equals one absence).

**Class Participation:** Each student is expected to participate during class/group discussions and be respectful of opinions that others may have.

**Assignments:** Application is key to comprehension. Be prepared. The purpose of assignments is to demonstrate understanding, writing skills, and provoke thought. All assignments are to be typed, using 12 point font, one inch margins, and be double spaced. Please have your name in the upper left hand corner along with the date the assignment was due. Late assignments will be accepted on a case by case basis and must be discussed with the instructor prior to the due date.

**Articles:** Each week, you will submit one-two articles that contains the summary of the article and your reaction/response to the article. It must relate to the one of the topics of the day, demonstrate

the class objective, and must be within the past three. The length of your reaction paper varies. The source of your article must be provided and it's degree of reliability will be evaluated.

Chapter Questions: As assigned by instructor and based on the textbook only.

**Research Paper:** The topic of your paper will reflect the class and must be approved by the instructor at the onset of class. The format of your paper must be APA with a minimum five pages. There is no maximum. You must use a minimum of three resources. You will be graded on knowledge of the topic, analysis, resources used, presentation, and the ability to abide by the stated structure. Resources will be reviewed to determine reliability and credibility. Late papers will be accepted on a case by case basis and must be discussed with the instructor prior to the due date.

**Exams:** Two exams given, midterm and final.

**Academic Policies:** Students are expected to comply with the standards related to academic honesty and plagiarism that are stated in the Chaminade General Catalog. Failure to adhere to these policies can result in a failing grade.
