Course Description:

An Examination of significant and controversial criminal justice topics, involving law enforcement agencies, primarily the police, clarifying, interpreting, and identifying the role of discretion in the system. Prerequisite: CJ151

Course Objectives

3. Will know the major studies, which have been conducted in law enforcement, tasks performed, and impact upon crime.
4. Will understand the role of law enforcement agencies today.
