Course Objective:

The emphasis will be to develop an understanding of the Correctional System in terms of process and function, and the role it plays in our Society. The roles of the various law enforcement agencies, court systems, police, social and political forces will be examined in the context of their affect on Corrections. Special emphasis will focus on Community Corrections and the impact it has on prisons. In the process of analysis a systems approach will be used to examine the interrelationships between Corrections and other institutions in Society.

- A. Class will consist of lectures, videos, student presentations, group discussions and journal reports.

- D. Attendance and class participation are expected and necessary requirement of this course. Absence from class will impact on the students grade.
- E. Student journals will contain various student projects, group discussion questions, film reviews, and weekly news releases on subjects keyed to material covered in class. Journals are expected to be brought to each class meeting. Completed journals will be collected at the night of the final.

VIGNETTE

The vignette requirement involves both a written evaluation and oral presentation of a journal article. The subject area will be assigned in class.
