Course Description and General Outline:

This course will examine patterns of deviancy in youths. Through a sociological perspective we will examine the impact of the family, school, and peers. We will also closely examine the classical criminological theories of juvenile delinquency causation.

Learning Objectives:

Students are encouraged to view this class as a unique learning experience as well as a forum of discussion where the free exchange of ideas and beliefs, as they relate to Juvenile Justice, is valued and encouraged.

This course is designed to equip the student with an understanding of the criminological/sociological factors believed to correlate with juvenile delinquency and deviancy. In addition, this course will build upon and add to the student's professional vocabulary and writing ability.

In the broader sense and in keeping with Chaminade University's tradition of Liberal Arts education, this course will encourage the student to think critically across the several disciplines that relate to the Criminal Justice System.
