Instructors Background:

Receiving my undergraduate degree from Chaminade University in Political Science and Criminal Justice, I continued in the graduate program and received my Master's of Science in Criminal Justice Administration. During this time, I also received my Juris Doctorate from the William S. Richardson School of Law. In reference to my Juvenile Justice background, I currently am a Deputy Prosecuting Attorney for the State and previously worked in the Family Court section with Juveniles for approximately three years. While in the Family Court division, I have worked closely with Juveniles, their social workers, probation officers, counselors and a variety of different agencies involved with Juveniles in the Criminal Justice System.

Course Objective:

The emphasis will be to develop an understanding of the Juvenile Deviancy/Justice in terms of process and function, and the role it plays within the Criminal Justice System. We will be discussing the interaction between Juveniles and their relationships with agencies such as: the police, court systems, and various law enforcement agencies. There will be an analysis section of our studies which will focus on the social and political forces affecting the Juveniles within the Criminal Justice System. As a special emphasis we will take a historical look at Juveniles, and their roles within the Criminal Justice System.
