#### Course Description and General Outline:

Discussion of the components of the Juvenile Justice System; comprehensive study of juvenile offenses and behavioral expectations in diverse environments; overview of theories relating to juvenile delinquency; methods of punishment; reviewing the effectiveness of treatment for juvenile delinquency. Students will be required to relate theoretical subject matter **will** current events.

#### Attendance:

Attendance comprises of one-third of the final class grade (refer to grading policy). Upon three absences a **deficiency** notice will be sent to the registrar with the recommendation that the student withdraw from the class. Group:	70 points - each student will be expected to <b>participate</b> actively in small group discussions relating to the class.
	100 points - the midterm exam will consist of the first half of the course material.
Final:	100 points - the final <b>exam</b> will consist of the second half of the course.

	<ul> <li>100 points - Students will prepare a written research paper (10 pages minimum, this does not include the title page nor the bibliography page) on any topic relating to juvenile delinquency in the criminal justice system and make an oral presentation to the class.
