Scope of the Course

This course surveys the key processes, events and personalities that have shaped the societies, states and economies of the Middle East since the 18th century, with a brief study of the region prior to that time.

- Part I of the course is a brief introduction to competing frameworks for understanding the place of the Middle East in the imaginations of peoples in Europe and the United States.
- Part II traces the historical evolution from empires to states by outlining the forces behind the emergence of new states and identities after the collapse of the Ottoman Empire that, until the First World War, had ruled much of this region for over 400 years.

- Part III examines how the social structures, economic dynamics, state institutions and ideological worldviews of the peoples of the region were shaped and transformed by nationalist struggles against British and French colonial rule and by state-led nation-building projects.
- Part IV looks at the post-independence period which was marked by ambitious economic development and social engineering projects on the one hand, and, on the other, devastating regional conflict in the context of the Cold War.
- Part V examines the causes and effects of increasing US economic and military interventions in the region from the time of the Islamic Revolution in Iran up until today.

Goals of the Course

- To contextualize current developments in the Middle East in terms of their historical, social, political, and economic backgrounds
- To identify various interpretative frameworks for approaching history in general and for understanding the Middle East in particular.

Course Requirements

- Regularly attend and actively participate in class meetings.

PLEASE NOTE: Every three (3) unexcused absences will reduce your semester grade by 10%. Students who miss two (2) consecutive weeks of class will be withdrawn.

- Satisfactory completion of all assignments as given throughout the course, including readings from the text and other handouts, two research papers, periodic essay assignments, and online discussion threads.

PLEASE NOTE: Written assignments submitted after the due date will be eligible for partial credit if submitted within seven (7) days after the due date. Assignments submitted after the seven day limit will not receive any credit.

- Satisfactory completion of the Mid-Term and Final Exams.

MARIANIST EDUCATIONAL VALUES

The five characteristics of a Marianist Education are:

1. Educate for Formation in Faith

Catholic Universities affirm an intricate relationship between reason and faith. As important as discursive and logical formulations and critical thinking are, they are not able to capture all that can be and ought to be learned. Intellectual rigor coupled with respectful humility provides a more profound preparation for both career and life. Intellectual rigor characterizes the pursuit of all that can be learned. Respectful humility reminds people of faith that they need to learn from those who are of other faiths and cultures, as well as from those who may have no religious faith at all.

2. Provide an Excellent Education

In the Marianist approach to education, “excellence” includes the whole person, not just the technician or rhetorician. Marianist universities educate whole persons, developing their physical, psychological, intellectual, moral, spiritual and social qualities. Faculty and students attend to fundamental moral attitudes, develop their personal talents and acquire skills that will help them learn all their lives. The Marianist approach to education links theory and practice, liberal and professional education. Our age has been deeply shaped by science and technology. Most recently, information and educational technologies have changed the way faculty and students research and teach. At Marianist Universities, two goals are pursued simultaneously: an appropriate use of information technology for learning, and the enhancement of interaction between students and teachers. As Catholic, Marianist Universities seek to embrace diverse peoples and understand diverse cultures, convinced that ultimately, when such people come together, one of the highest purposes of education is realized: a human community that respects every individual within it.

3. Educate in Family Spirit

Known for their strong sense of community, Marianists have traditionally spoken of this sense as “family spirit.” Marianist educational experience fosters the development of a community characterized by a sense of family spirit that accepts each person with loving respect, and draws everyone in the university into the challenge of community building. Family spirit also enables Marianist universities to challenge their students, faculty and staff to excellence and maturity, because the acceptance and love of a community gives its members the courage to risk failure and the joy of sharing success.

4. Educate for Service, Justice, and Peace

The Marianist approach to higher education is deeply committed to the common good. The intellectual life itself is undertaken as a form of service in the interest of justice and peace, and the university curriculum is designed to connect the classroom with the wider world. In addition, Marianist universities extend a special concern for the poor and marginalized and promote the dignity, rights and responsibilities of all people.

5. Educate for Adaptation to Change

In the midst of rapid social and technological change, Marianist universities readily adapt and change their methods and structures so that the wisdom of their educational philosophy and spirituality may be transmitted even more fully. “New times call for new methods,” Father Chaminade often repeated. The Marianist university faces the future confidently, on the one hand knowing that it draws on a rich educational philosophy, and on the other fully aware for that philosophy to remain vibrant in changing times, adaptations need to be made.
