# **Biography:**

After joining the Honolulu Police Department in 1980, I was fortunate to have had various patrol (i.e., Waikiki, central Honolulu, Pearl City, Kalihi, Wahiawa districts) and non-patrol assignments [i.e., Receiving Desk, Criminal Investigations (General-First Watch, Forgery, and Child Sex Crimes Details), Community Relations, Records and Identification, Communications, Traffic] throughout my career. I held the rank of captain at my last regular assignment with the Pearl City patrol district (as the executive officer) and retired in December 2012. In January 2013, I joined the Honolulu Police Department's Reserve Officer program and I currently serve as a reserve police officer assigned to the Training Division.

I have a Bachelor of Science degree (Occupational Education specializing in Criminal Justice) and a Master of Arts degree in Management (specializing in Human Resource Management). I also completed additional graduate course work from the University of Phoenix, the University of Hawaii – Manoa, and Northcentral University.

Besides being a part-time lecturer at Chaminade University, for the last fourteen years I taught and still teach criminal justice administration courses at other institutions of higher education.

## **Course Description:**

Study of the major theories of management, organizing, motivation and leadership, and decision-making as applied to criminal justice personnel. This course provides competencies to meet the program outcome to allow students to demonstrate an understanding of a model of criminal justice management theory and practice, stressing conceptual, methodological and contextual knowledge development and application.

### **Student Learning Outcomes:**

Students completing this course will demonstrate an understanding as to:

- 1. how law enforcement got to where it is today
- 2. current police operational philosophies
- 3. how national and domestic terrorism have impacted on the role of police agencies
- 4. the importance of politics in policing
- 5. how to organize law enforcement agencies from theoretical and practical perspectives
- 6. understanding the different approaches to leading a law enforcement agency
- 7. the planning and decision-making models for law enforcement agencies
- 8. the legal and practical aspects of human resource management in a law enforcement agency
- 9. organizational communication within law enforcement agencies
- 10. obtaining financial resources for a law enforcement agency

## **Course Requirements:**

- Weekly Discussion Questions: Two discussion questions (DQ) will be posted each week and a substantive response is required as well as a substantive secondary response to at least one of your classmate's responses for each question. To earn full discussion points, each response (initial and secondary) should be at least 100 words in length and of college level quality involving high-level thinking and simply not agreeing with the author (of the DQ) or with your classmate. Please post your responses within the appropriate assignment tab. [10 weeks x 2 DQs x 1.5 points each = 30 points]
- Video Review: In selected weeks, you will review an online video related to a specific supervision/management issue and you will provide your assessment of it. Your response should be at least 200 words in length and of college level quality involving high-level thinking. A substantive secondary response to at least one of your classmate's responses (of at least 200 words in length and of college level quality involving high-level thinking) is also required. Please post your work within the appropriate assignment tab.[2 video reviews x 10 points each = 20 points]
- News Article: In selected weeks, you will be given a news article related to a specific supervision/management issue and you will provide your assessment of it. Your response should be at least 200 words in length and of college level quality involving high-level thinking. A substantive secondary response to at least one of your classmate's responses (of at least 200 words in length and of college level quality involving high-level thinking) is also required. Please post your work within the appropriate assignment tab. [2 news articles x 10 points each = 20 points]
- **PowerPoint Presentation**: You will have a PowerPoint (PPT) presentation to prepare for this course. Your PPT presentation is expected to be between 12 and 15 slides to include a title slide and a "Questions" slide. Reference citations are absolutely required in the notes section of "each slide" (**do not include a separate references slide**); failing to cite will negatively affect your score! This PPT presentation is due on Sunday, September 8, 2019 [see Course Schedule (below)]. Note that late submittals will be penalized 10% per day and will not be accepted after five days (Friday, September 13, 2019).

The PPT presentation should be a biographical research of an individual, living or dead, who has "significantly" contributed to our country's criminal justice system. Please post a message (so others will see your choice) with the name of the individual you've chosen and once I confirm your choice you may begin your research. Each student will do research on their chosen "individual"; there will be no duplicates so it will behoove you to submit the name of your individual as early as possible.

The PPT presentation is expected to be prepared at a college skill level with few if any grammatical errors, is well-written, thought-provoking, well-researched, and clearly communicates the scope of the objectives for the assignment. You are expected to prepare your own presentation. Plagiarism is a serious offense (and I do check for plagiarism in my courses). If I find evidence of plagiarism, in part or in full, you will receive 0 points for this assignment. This PPT presentation is worth 15% of your final course grade.

Final Exam: You will have one examination for this course, a final at the end of the semester. The exam will cover items from the text, supplemental reading/viewing materials, discussions, or other media used throughout the class. The exam will consist of true/false and multiple choice questions and will be worth 15% of your final grade. No make-up exams will be given unless you are able to document a personal or medical emergency. The final exam will be administered via the Canvas Learning Management System.

• **Assignments:** Course assignments will be posted by or before Monday morning; check due dates/times on the Canvas learning management system.

## **Academic Honesty**

#### SCIENTIFIC METHOD DEFINITIONS

- The **METHODS OF SCIENCE** are only tools, tools that we use to obtain knowledge about phenomena.
- The SCIENTIFIC METHOD is a set of assumptions and rules about collecting and evaluating data. The explicitly stated assumptions and rules enable a standard, systematic method of investigation that is designed to reduce bias as much as possible. Central to the scientific method is the collection of data, which allows investigators to put their ideas to an empirical test, outside of or apart from their personal biases. In essence, stripped of all its glamour, scientific inquiry is nothing more THAN A WAY OF LIMITING FALSE CONCLUSIONS ABOUT NATURAL EVENTS.

Knowledge of which the credibility of a profession is based must be objective and verifiable (testable) rather than subjective and untestable.

SCIENCE is a mode of controlled inquiry to develop an objective, effective, and credible way of knowing.

The assumptions one makes regarding the basic qualities of human nature (that is, cognitive, affective, behavioral, and physiological processes) affect how one conceptualizes human behavior.

The two basic functions of scientific approach are 1) advance knowledge, to make discoveries, and to learn facts in order to improve some aspect of the world, and 2) to establish relations among events, develop theories, and this helps professionals to make predictions of future events.

Research Design in Counseling Heppner, Kivlighan, and Wampold

- A THEORY is a large body of interconnected propositions about how some portion of the world operates; a
   HYPOTHESIS is a smaller body of propositions. HYPOTHESES are smaller versions of theories. Some are
   derived or born from theories. Others begin as researchers' hunches and develop into theories.
- The **PHILOSOPHY OF SCIENCE** decrees we can only falsify, not verify (prove), theories because we can never be sure that any given theory provides the best explanation for a set of observations.

Research Method in Social Relations

■ **THEORIES** are not themselves directly proved or disproved by research. Even **HYPOTHESES** cannot be proved or disproved directly. Rather, research may either support or fail to support a particular hypothesis derived from a theory.

Scientific research has four general goals: (1) to describe behavior, (2) to predict behavior, (3) to determine the causes of behavior, and (4) to understand or explain behavior.

Methods In Behavioral Research; Cozby

• In order to verify the reliability and validity of scientific research it is important to replicate the results. It is the preponderance of evidence that establishes/supports the theory.
