University Course Catalog Description

FS 460 Forensic Taphonomy (3) Processes associated with the decomposition and preservation of organic materials with an emphasis placed on human remains. *Prerequisites: CH 323/L. Concurrent registration in FS 460L required.*

Course Learning Outcomes (CLO)

You are now a Decomponaut. As a Decomponaut you are a member of an elite team of scientist diplomats that specialize in death and decomposition. Kind of like the A-Team, if they were significantly more awesome. This class will teach you the importance of death and decomposition to our planet. You will also learn how nature, including human activity, affects decomposition and how decomposition can be used as evidence in medicolegal death investigation. As a result, you will finish this class with the ability to:

- 1. Identify and discuss processes of decomposition.
- 2. Define and discuss the effect of environmental variables on decomposition.
- 3. Discuss the application of taphonomy to medicolegal death investigation.

4. Discuss the value of common and recently developed techniques in forensic taphonomy.

- 1. Apply the scientific method in an adaptive and mindful manner
- 2. Use techniques for recognition, documentation, analysis, and interpretation of physical evidence

Alignment of Course and Program Learning Outcomes

Marianist Characteristics & Native Hawaiian Values

- 3. Educate in Family Spirit ('Ohana) 'Ike aku, 'ike mai, kōkua aku kōkua mai; pela iho la ka nohana 'ohana ('Ōlelo No'eau 1200) Recognize others, be recognized, help others, be helped; such is a family relationship
- 4. Educate for Service, Justice and Peace (Aloha) Ka lama kū o ka no'eau ('Ōlelo No'eau 1430) Education is the standing torch of wisdom
- 5. Educate for Adaptation and Change (Aina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203) All knowledge is not taught in the same school

This class will focus on an education in the forensic sciences as an education in service, justice, and peace. This class will provide you with an opportunity to acquire an integral, quality set of skills that will help you to provide service, justice, and peace to the recently deceased and bereaved. You will also that most forensic scientists are public servants that conduct science for the benefit of society. Forensic scientists analyze, and speak for, evidence so that justice can be served and peaceful society can flourish.

Required Learning Materials

This class requires the use of several learning materials, both electronic and physical. This class will be managed electronically through Canvas and Google. All learning materials will be provided.

Canvas

Canvas will serve as the primary repository for university documents and your grade, which will be updated each week. Canvas will also be used for email communication.

Lectures & Class Meetings

We will meet live during the first week of classes. This will allow us to review the syllabus and address any issues that develop. Starting in week 2, lectures will be delivered asynchronously so that you can watch them at the time that best serves you and <u>we will meet live every Friday thereafter at the normally scheduled class time</u>. You will earn two points per class attended. Zoom invitations will be provided.

EVALUATION OF STUDENT PERFORMANCE

All grades will be posted in Canvas within one week of submission/exam completion. Attendance grades will be posted to Canvas on a weekly basis. Your grade will be kept current all semester. Exams

You are required to complete four exams via Google Forms. These exams are modelled after forensic science certification and accreditation exams, which means they are in multiple choice format including true/false. Each exam is worth 50 points.

The Decomponauts – Diplomats of Death and Decomposition

The world is sorely in need of forensic scientists that have a robust understanding of medicolegal death investigation and taphonomy in particular. The great thing is that you are just the person to provide it. First step – we need to establish your identity, which will be shared using the Canvas Discussion Board. Your initial post will answer these questions:

- 1. What is your Decomponaut codename?
- 2. Why did you choose that codename?
- 3. In which area of taphonomy do you want to specialize:
 - a. Anthropology
 - b. Chemistry
 - c. Entomology
 - d. Microbiology
 - e. Scavenger Ecology

You must then reply to at least one classmate by telling them (1) why you like their codename and why you think their area of expertise is (2) interesting and (3) valuable to medicolegal death investigation. By the way, my codename is Doc. This assignment will occur during weeks 5 and 6 of the semester. Late posts and late replies will be penalized 10 points per day late.

Carcass Image Collection – Long Term Project

Carcasses are everywhere, you probably just don't realize it. To foster your appreciation of carcass ubiquity, you must collect 10 images of carcasses that you have encountered during the semester. You will then be placed into groups of 2 - 3 students and your job is to develop a slide show of your Top 10 Carcasses. Each of your Top 10 must have a brief note explaining why it made the Top 10. You will include the remaining 10 - 20 carcasses as the runners up.

Carcasses must be animals (e.g. mammals, birds, insects, reptiles, fish) and images can be captured using your smartphone. You will probably find most carcasses around your home or while you are outside. You must (1) identify each carcass to the best of your ability, (2) document the location where you found it and (3) present them as a slideshow in Google Slides. An example slideshow will be provided to you. Your Carcass Image Collection is due on Friday, 20 November. Late assignments will be penalized 10 points per day late.
