Zoom Classroom:

On the first day of the course, we will meet in a zoom classroom. The details of the zoom room will be communicated in canvas.

Course Functioning

Students will be responsible for reading the case scenario, standard operating procedure, and any other relevant information before attending the first casework laboratory.

Students will come to the peer review days with a completed lab case file.

Case files will be due the week following the peer review week, and must be submitted in canvas by the end of the day on the Wednesday preceding the laboratory.

Late Work and Absence Policy

We recognize that we are living in extraordinary times and that each student's situation can change rapidly. It is important to *communicate with your instructor* so that they can help you to meet the learning objectives of the course.

Unexcused absences will result in 0 points for any associated in-class assessments

Unexcused absences for two consecutive weeks, without communication with the course instructor, may result in being withdrawn from the course by the instructor.

A planned, excused absence must be communicated to the instructor at least one week prior to the laboratory when possible. Necessary arrangements will be made to meet student learning objectives.

An unplanned, excused absence must be communicated to the instructor within one week of the missed laboratory. Necessary arrangements will be made to meet student learning objectives.

Determination of valid excuses for missed classes is at the sole discretion of the instructor.

Student athletes should communicate absences to the instructor with the earliest possible notice and in writing by e-mail. Students are not allowed to miss class for practices.

Late assignments will have 10% per day deducted from the total score. Peer review assignments will be assigned a grade of zero if they are not submitted by the deadline.

- 4. Educate for Service, Justice and Peace (Aloha) Ka lama kū o ka no'eau ('Ōlelo No'eau 1430) Education is the standing torch of wisdom
- 5. Educate for Adaptation and Change (Aina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203) All knowledge is not taught in the same school

Academic Integrity

Unexcused absences equivalent to more than a week of classes may lead to a grade reduction for the course. Any unexcused absence of two consecutive weeks or more may result in being withdrawn from the course by the instructor, although the instructor is not required to withdraw students in that scenario. Repeated absences put students at risk of failing grades.

Students with disabilities who have obtained accommodations from the Chaminade University of Honolulu Tutor Coordinator may be considered for an exception when the accommodation does not materially alter the attainment of the learning outcomes.

Federal regulations require continued attendance for continuing payment of financial aid. Credit Hour Policy

The unit of semester credit is defined as university-level credit that is awarded for the completion of coursework. One credit hour reflects the amount of work represented in the intended learning outcomes and verified by evidence of student achievement for those learning outcomes. Each credit hour earned at Chaminade University should result in 45 hours of engagement. This equates to one hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for approximately fifteen weeks for one semester, 10 week term, or equivalent amount of work over a different amount of time. Direct instructor engagement and out-of-class work result in total student engagement time of 45 hours for one credit.

The minimum 45 hours of engagement per credit hour can be satisfied in fully online, internship, or other specialized courses through several means, including (a) regular online instruction or interaction with the faculty member and fellow students and (b) academic engagement through extensive reading, research, online discussion, online quizzes or exams; instruction, collaborative group work, internships, laboratory work, practica, studio work, and preparation of papers, presentations, or other forms of assessment. This policy is in accordance with federal regulations and regional accrediting agencies.

The instructor may modify elements of this syllabus according to the operational needs of the class.
