## **University Course Catalog Description**

Professional Internship. Career development seminar course plus on-or off-campus internship placements. 45 hours internship required per credit. May be repeated for credit, up to 6 credits may be applied to major. Pre-requisites: Junior or Senior standing, BI 215/L (Biology majors) or ENV 201/L (ENV majors).

## Course Overview

As the title indicates this course consist of a supervised internship or a field experience at a business or cooperating agency. This is an upper- division course enrolling Juniors and Seniors. This course provides an opportunity to complete volunteer biology or environmentally related work at cooperating community agencies. Supervision is provided by an instructor at Chaminade University, and by the immediate supervisor at the agency. Enrolled students receive semester credits based upon the amount of hours the student conducts work for the agency during the 15 weeks of the semester or hours completed plus an additional reflection paper. Credits can vary from 1-3 semester credits (see Course Assessment). Hours of work obtained during the summer can be applied for the fall course upon previous agreement with the BI387 instructor. Students volunteering at the agencies do not receive payment for services under normal circumstances. Paid internships may qualify for BI387 credit; students are encouraged to discuss this with the BI387 instructor.

## Course Prerequisites

Biology students will have completed BI215 and BI215L; Environmental Studies and Environmental Science majors will have completed ENV 201 and ENV 201L.

## Course Assessment

The primary assessment is based on completion of 45 hours supervised internship or volunteer activity in service at an agency or business (Option A). Forty-five hours volunteer or internship is equivalent to the 3 hours per week throughout a semester for a lab class (Carnegie unit). If the student expects that fewer than 45 hours can be completed, then Option B may be substituted by agreement with the instructor. Option B adds requirements

of written papers, a reflection paper and or topic review, depending on the number of credits student have registered.

### All students will need to

- Complete hours with agency (225 points)
- Create, maintain, and share weekly with the instructor a logbook for hours and description of activities (2 points per week, 30 points total)

- submit all required forms, signed by supervisor, to verify the agency at which the field experience will occur (midterm: 5 pts, end term: 10 points)
- provide a 5 minute, end-of-the-semester presentation to the class about the field experience (20 points)
- complete an Exit Survey about their internship/field experience (10 points)

For Option B, students will also need to

- 1. Submit 5 page Topic Reflection paper, APA format
- 2. Submit 5 page Topic Review paper, APA format
- 3. Submit topical poster presentation at departmental seminar or equivalent

A total of 300 available points.

## **Grading Scale**

Letter grades are given in all courses except those conducted on a credit/no credit basis. Grades are calculated from the student's work described in Course Assessment.

270 points or more = A grade

240 - 269 points = B grade

210- 239 points = C grade

180 - 209 points = D grade

179 points or fewer = F grade

The letter grades are interpreted as follows:

A Outstanding scholarship and an unusual degree of intellectual initiative

B Superior work done in a consistent and intellectual manner

C Average grade indicating a competent grasp of subject matter

D Inferior work of the lowest passing grade, not satisfactory for fulfillment of prerequisite course work

F Failed to grasp the minimum subject matter; no credit given

Students are expected to attend regularly all courses for which they are registered. Student should notify their instructors when illness or other extenuating circumstances prevents them from attending class and make arrangements to complete missed assignments. Notification may be done by emailing the instructor's Chaminade email address, calling the instructor's campus extension, or by leaving a message with the instructor's division office. It is the instructor's prerogative to modify deadlines of course requirements accordingly. Any student who stops attending a course without officially withdrawing may receive a failing grade. Unexcused absences equivalent to more than a week of classes may lead to a grade reduction for the course. Any unexcused absence of two consecutive weeks or more may result in being withdrawn from the course by the instructor, although the instructor is not required to withdraw students in that scenario. Repeated absences put students at risk of failing grades. Students with disabilities who have obtained

accommodations from the Chaminade University of Honolulu ADA Coordinator may be considered for an exception when the accommodation does not materially alter the attainment of the learning outcomes. Federal regulations require continued attendance for continuing payment of financial aid. When illness or personal reasons necessitate continued absence, the student should communicate first with the instructor to review the options. Anyone who stops attending a course without official withdrawal may receive a failing grade or be withdrawn by the instructor at the instructor's discretion.

#### Online Attendance

During the first three weeks (subject to change), this course is primarily online. Attendance for this course during the online phase is based on the (1) timely submission of assignments and/or (2) logging onto the course at least once per week. Students will receive credit for 'attending' the class each time a weekly assignment is submitted and/or each time student signs on to the course and navigate to at least one page or module removed from the home page within the Canvas system for the course. Some weekly lessons require the submission of one assignment, some require two. Each lesson will indicate when it is complete. The student is responsible for pressing the 'submit' button each time he or she has completed an assignment. If the page indicating that the assignment has been submitted does not appear, then the assignment has not been submitted.

## Late Work Policy

There are no make-ups for quizzes, unless a physician's note documents your absence during quizzes. Journal article presentations CANNOT be made-up. Quizzes and assignments are due by 8:59am HST on the assigned date. Up to 10% grade reduction will be assessed for each 12 hour late assignment. All quizzes and assignments close by 3 days post the due date.

## Grades of "Incomplete"

Students and instructors may negotiate an incomplete grade when there are specific justifying circumstances. An Incomplete Contract (available from the Divisional Secretary and the Portal) must be completed. When submitting a grade, the "I" will be accompanied by the alternative grade that will automatically be assigned after 90 days. These include IB, IC, ID, and IF. If only an "I" is submitted the default grade is F. The completion of the work, evaluation, and reporting of the final grade is due within 90 days after the end of the semester or term. This limit may not be extended.

- Submitting as one's own original work, however freely given or purchased, the original exam, research paper, manuscript, report, computer file, or other assignment that has been prepared by another individual.
