This course examines the complex economic, political, and social challenges that leaders face as they seek to meet the needs of diverse organizations and constituents. Students will consider economic disparity, power, and privilege and how they impact ethics and social justice.

- Not providing adequate references for cited work.
- Copying and pasting large quotes or passages without properly citing them.
