# **Catalog Course Description**

This course provides an introduction to the principles and procedures of Auditing.

# Program Learning Outcome (Course Objectives)

- 1. Apply the technical aspects of financial accounting and reporting.
- 2. Explain the key concepts of auditing and attestation services.
- 3. Recall the fundamentals of traditional ethical concepts and principles, identify ethical issues, utilize skills in making ethical judgements and summarize current knowledge of professional standards and legal issues.


This course is intended to provide both theoretical and practical knowledge in auditing concepts. Students practice and mastery of the program learning outcomes will prepare students for careers in auditing as well as preparation for the CPA Examination.

Accounting is a very difficult subject area. Consequently, students will be expected to contribute a significant amount of time outside of the classroom during the Semester. It is expected that students will need to spend a minimum of 12 - 15 hours per week outside of class to succeed in this course.

# **Course Learning Outcomes**

At the conclusion of this course, successful students will have (followed by the list of learning outcomes):

- 1. An ability to explain procedures used in assurance & non-assurance services to evaluate the financial and operational activity of a given organization.
- 2. An ability to appraise from Generally Accepted Auditing Standards and the AICPA Code of Conduct appropriate methods to apply in evaluating areas of a given organizations Financial Activity.
- 3. An Ability to evaluate assurance & non-assurance case studies to assemble of GAAP based response or recommendation.



# **Mini Exams**

As indicated on the course schedule, there will be three exams worth 50 points each. Will be both In Class and take home. The take home sections of all exams will be due at indicated times by submissions into the applicable exam drobox in Canvas. Students will loose 15% from their raw score for each day take home sections are past due up until the date the professor reviews the exam. Student who have not submitted their exams prior to the professor's review will receive an automatic zero on those parts of their exams.

# **True Blood Class Cases**

Students will work through case studies drawn from the profession that cover fraud and forensic related audit topics that will help to prepare students for questions and activities likely arise when they enter into professional practice. Students will be pared in a group of 2 to 3 and assigned different task deliverables to complete on both an individual and group level as they work through these various "gray" areas of accounting together. Each case will be worth 40 points each.

#### **Comprehensive Class Project**

The class will work as consultants to the AC-201 student. In advising them on managing and accounting for the operating activity of the given theoretical businesses. As financial business consultants, students should keep track of and will be evaluated on the following.

- 1) A contract with the AC-201 students that falls in line with AICPA Contract law that also follows the AICPA Code of Professional Conduct.
- 2) A Budget tied to the contract with the AC-201 students that includes a billable log of time to be spent working on determined task to fulfill the responsibilities outlined in the contract. The accountant should always perform their work with a duty of care and other professional characteristics outlined in the AICPA Code of Professional Conduct.
- 3) Linking Each client task performed to the AICPA Code of Conduct Review, Audit, Consulting, Tax or other standards outlined at <a href="https://www.aicpa.org">www.aicpa.org</a>.

We will address the detail of how this project will be initiated and evaluated throughout the semester during class.
