

Catalog Course Description

This course provides an introduction to the application of principles and procedures introduced in AC-404 to the process of Auditing.

Program Learning Outcome (For Accounting)

- 1. Apply the technical aspects of financial accounting and reporting
- 2. Apply operational and managerial accounting skills
- 3. Distinguish the differences between governmental accounting and reporting principles and those of financial reporting for for-profit entities
- 4. Explain the key concepts of auditing and attestation services
- 5. Compile federal and state income tax returns for individuals
- 6. Demonstrate critical thinking and problem-solving skills and utilize communication and group collaboration
- Recall the fundamentals of traditional ethical concepts and principles, identify ethical
 issues, utilize skills in making ethical judgements and summarize current knowledge of
 professional standards and legal issues.
- 8. Understand the value of community service and service learning through experiential projects.

This course is intended to provide both theoretical and practical knowledge in auditing concepts. Students practice and mastery of the program learning outcomes will prepare students for careers in auditing as well as preparation for the CPA Examination.

Accounting is a very difficult subject area. Consequently, students will be expected to contribute a significant amount of time outside of the classroom during the Semester. It is expected that students will need to spend a minimum of 12 – 15 hours per week outside of class to succeed in this course.

Course Learning Outcomes

At the conclusion of this course, successful students will be able to (followed by the list of learning outcomes):

- 1. Examine and prescribe the appropriate Audit, Attest & Quality Control Standards promulgated by the Auditing Standard Board(ASB) to apply in constructing audit programs to assess assurance and non-assurance operational, management and oversight accounting practices being used by business.
- 2. Determine the appropriate Part of the AICPA Code of Professional Conduct to apply when conducting attestation and non-attest procedures.
- 3. Comply with GAAS in testing audit evidence employing appropriate methods outlined in standards to be followed in reconciling, sampling, evaluating, reviewing and concluding on applicable accounts of classes of transaction found on financial reports.



Each Thursday will be used to work on parts assigned from various Trueblood Cases that will need to be turned in the appliable drobox in Canvas. You will be provided a series of resources that you may use to assist in the completion of the parts assigned each Thursday.

Trueblood Background:

The Trueblood student cases are prepared by Deliotte professionals. They are based on recent technical issues that often require significant research and judgment. The case topics will highlight the "gray" areas of accounting and help prepare students for the types of questions likely to arise in professional practice.
