Catalog Course Description

This is a basic, introductory course, which covers material essential to an understanding of personal financial management. Topics will include, but not be limited to, consumer credit and loans, automobile and housing decisions, insurance, tax strategies, retirement planning and insurance.

Credit Hour Description

This is a three credit hour course requiring 135 clock hours of student engagement, per the official CUH Credit Hour Policy. Students enrolled in this course are expected to spend about 40.66 in class, 3 hours writing response cases/projects, 10 hours studying for the midterm exam, 24 hours revising course cases/projects, and 10 hours studying for the final exam. There will be an additional 47.34 hours of work required beyond what is listed here (course readings, homework assignments, etc.). This additional work will average about 3 hours per week.

Fall Term Project

You will have one fall term project due on Monday November 25th 2024.

Term Project Background:

During the semester you will learn about numerous ideals surrounding an individual's past, present, and future financial well-being (health). Topics of the classes' text give insight into how these ideals are identified, assessed, and used to further individuals on their financial life's journeys. This project will answer six key questions of each students anticipated financial life journey, which will continue to change as one progresses through life.

- 1. What is My Financial Behavior?
- 2. What Are My Short Term Financial Goals?
- 3. What Are My Long Term Financial Goals?
- 4. How Do I Achieve Those Financial Goals?
- 5. How Does Savings Play Into My Goals?
- 6. What Are The Different Types of Savings Strategies Do I Need To Employ To Reach My Goals?

Project Assignment Step Process:

- I. For the first Month of class (August 22, 2024 to September 19, 2024) students will collect all receipts from cloths, food, entertainment, travel, supplies, utilities, donations, tithing, gifts, penalties, interest, medical out of pocket, and any other costs one may have incurred(spent money on) over the first 30 days of class. Students will be provided with their own copy of a receipt book to keep as back-up for instances when a purchase or gift does not produce an actual tangible receipt. Students will be able to draft copies of the transactions by noting the date, amount, organization/person, description and payment method (credit card, cash, financing option, or other). Students will also collect all employment paystubs, parent/guardian allowances, cash gifts and current portions of loans received during the first 30 days of instruction. The collected information should be maintained within a shoebox or an alternative container (something small simple and cheap that you can maintain for an entire month). {At Home}
- Using the financial template provided by the professor students will itemize all cash II. inflows and outflows into their appropriate category to complete the personal cash flow statement and personal balance sheet. {In-Class & At Home}

- III. After completing your personal cash flow statement and balance sheet, you'll engage in a self-assessment by analyzing each line item. To enhance this process, we will use AIdriven tools that will assist you in identifying patterns in your financial behavior. The AI will categorize each of your financial activities as either acceptable or unacceptable based on the data you've input. This personalized analysis will provide insights into your spending habits and suggest areas for improvement. To utilize this AI analysis, you will input your financial data into the provided template, and the AI tool will automatically assess your entries. This will help you better understand your financial behavior and make more informed decisions about your financial goals and strategies. (Only You Will Know That – Personal Analysis). {In-Class & At Home}. AI-Project Integration
- List out 2 short term financial goals (attainable within a single month). One of these goals IV. should be pulled from the class textbook. {In-Class}
- V. List 2 long term financial goals (attainable between 5 and 10 years). One of these goals should be pulled from the class textbook. {In-Class}
- Form a financial advisory team of 4 to 5 of your classmates and discuss with your VI. professor and team ways in which you should think about altering your financial behavior to reach your financial goals. As you form your financial advisory team, collaboration will be key to successfully completing the project. To facilitate effective communication and coordination within your team, we will be using AI-powered collaboration tools. These tools will help manage team tasks, set reminders for upcoming deadlines, and ensure that all team members are aligned and on track with the project objectives. The AI assistant will also be available to help with organizing meetings, tracking progress, and providing summaries of discussions. This will enable you to focus on the content of your discussions rather than the logistics, enhancing the overall efficiency and effectiveness of your teamwork. AI-Project Integration
- VII. Work with your team and professor to flush out at least 4 formal budgetary assumptions that you will use to develop your budget for the next phase of your term project.
- Financial advisory team will work with the professor to develop formulas from the VIII. assumptions produced. These formulas will be used to covert the actual behavior captured in "II" into a budgetary set of personal financial statements used to measure the next 30 days beginning October 24th and ending November 24th.
 - IX. Repeat the process undertaken in "II" for this new set of personal inflow and outflow
 - Use the budget to actual template provided by your professor place our budgetary and X. second set of actual data into the appropriate areas and calculate the differences between
 - XI. Classify each difference as favorable or unfavorable; for all the favorable outcomes provide financial behavioral enhancements that can increase those differences, and for all the unfavorable outcomes determine whether the budget needs to be revised or financial behavior needs to continue to be altered.

Students will lose 5% from your raw score for each day exams are past due up until the date the professor reviews the exam. Students who have not completed their exams prior to the professor's review will receive an automatic zero for that exam.
