

Catalog Course Description

This course examines the theory and practice of auditing as applied to transaction cycles, auditing terminology, internal control procedures, reporting on audited statements, audit evidence, and review and analysis of statements on auditing standards. Service-Learning.

- 1. Apply the technical aspects of financial accounting and reporting
- 2. Apply operational and managerial accounting skills
- 3. Distinguish the differences between governmental accounting and reporting principles and those of financial reporting for for-profit entities
- 4. Explain the key concepts of auditing and attestation services
- 5. Compile federal and state income tax returns for individuals
- 6. Demonstrate critical thinking and problem-solving skills and utilize communication and group collaboration
- 7. Recall the fundamentals of traditional ethical concepts and principles, identify ethical issues, utilize skills in making ethical judgements and summarize current knowledge of professional standards and legal issues.
- 8. Understand the value of community service and service learning through experiential projects.

- 5. Educate for Adaptation and Change (Aina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203) All knowledge is not taught in the same school

This course is intended to provide both theoretical and practical knowledge in auditing concepts. Students practice and mastery of the program learning outcomes will prepare students for careers in auditing as well as preparation for the CPA Examination.

Accounting is a very difficult subject area. Consequently, students will be expected to contribute a significant amount of time outside of the classroom during the Semester. This is a three credit hour course requiring 135 clock hours of student engagement, per the official CUH Credit Hour Policy. Students enrolled in this course are expected to spend about 40.66 in class, 3 hours writing response cases/projects, 10 hours studying for the midtern exam, 24 hours revising course cases/projects, and 10 hours studying for the final exam. There will be an additional 47.34 hours of work required beyond what is listed here (course readings, homework assignments, etc.). This additional work will average about 3 hours per week.



Midterm Exams

As indicated on the course schedule, there will be one midterm exams worth 100 points. There will two portions of the exam part in class and part take home. The take home section will be due as indicated in the applicable exam drobox in Canvas. Students will loose 5% from their raw score for each day take home sections are past due up until the date the professor reviews the exam. Student who have not submitted their midterm exams prior to the professor's review will receive an automatic zero on those parts of their exams.

True Blood Class Cases

Students will work through case studies drawn from the profession that cover fraud and forensic related audit topics that will help to prepare students for questions and activities likely arise when they enter into professional practice. Students will be pared in a group of 2 to 3 and assigned different task deliverables to complete on both an individual and group level as they work through these various "gray" areas of accounting together. The case will be worth 50 points.

Comprehensive Class Project

The class will work as consultants to the AC-201 student. In advising them on managing and accounting for the operating activity of the given theoretical businesses. As financial business consultants, students should keep track of and will be evaluated on the following.

- 1) A contract with the AC-201 students that falls in line with AICPA Contract law that also follows the AICPA Code of Professional Conduct.
- 2) A Budget tied to the contract with the AC-201 students that includes a billable log of time to be spent working on determined task to fulfill the responsibilities outlined in the contract. The accountant should always perform their work with a duty of care and other professional characteristics outlined in the AICPA Code of Professional Conduct.
- 3) Linking Each client task performed to the AICPA Code of Conduct Review, Audit, Consulting, Tax or other standards outlined at www.aicpa.org.

We will address the detail of how this project will be initiated and evaluated throughout the semester during class.
