5. Carefully analyze and synthesize material and ideas borrowed from sources. In addition, the sources of the borrowed material should be correctly acknowledged to avoid plagiarism (see Plagiarism).

Academic Honesty

Disability Access

There will be additional work required beyond what is listed here (collaborating with Dissertation Chair) and other activities associated with writing/researching a dissertation prospectus.

Attendance Policy

As stated in the Chaminade University Catalog, students are expected to attend all classes for courses in which they are registered.
