Catalog Course Description

Use of accounting data to make management decisions. Students will learn how accounting information is used to make strategic management decisions. Cost-Volume-Profit analysis, cost estimation, budgeting, short and long term financial decisions are studied from a managerial perspective.

Associated Program Learning Outcome (Course Objectives)

This course is intended to provide students without an undergraduate business major with the basic accounting knowledge to progress in strategic accounting management concepts necessary to make informed business decisions. Emphasis is placed on understanding the basic financial statements of an entity and the impact changes in the elements found specifically on the income statement and the balance sheet have on a given company's performance. Students are expected to apply this understanding to progress through various management concepts necessary for strategic decision making.

Decision making through the use of accounting is a difficult subject area. Consequently, students will be expected to contribute a significant amount of time outside of the classroom during the quarter. This is a master level course requiring 135 clock hours of student engagement, per the official CUH Credit Hour Policy. Students enrolled in this course are expected to spend about 40.66 in class, 4 hours writing response cases/projects, 10 hours studying for the midterm exam, 24 hours revising course cases/projects, and 10 hours studying for the final exam. There will be an additional 47.34 hours of work required beyond what is listed here (course readings, homework assignments, etc.). This additional work will average about 4 hours per week.

- 1. Select, analyze and evaluate financial data to propose key strategic management decisions.

- 3. Collect, analyze and evaluate economic data to formulate optimal strategic management decisions.
- 4. Collect, analyze and evaluate marketing information to create effective plans for value
- 5. Create strategic plans by analyzing, selecting, synthesizing information from diverse functional information sets.
- 6. Students will create and deliver professional business reports through multiple communication modalities (written, oral and digital).
- 7. Students will evaluate organizational decision making in light of social and environmental impact, social justice and the flourishing of society within the Marianist education framework.

At the conclusion of this course, successful students will have demonstrated (followed by the list of learning outcomes):

- 1. A moderate understanding of financial accounting and recognition of its importance in the business world.
- 2. How to utilize financial accounting in making good decisions about the functions of an organization.
- 3. How financial information is delivered to decision makers such as investors and creditors.
- 4. Application of various costing tools utilized by managers to develop plans of action that would impact strategies for implementation.
- 5. Moderate level of understanding of how to interpret managerial performance measures for effective decision making.

Quizzes

There will be one quiz during the course of the semester that will be worth 60 points each. The quiz will be short answers and will cover materials from previous class sessions. The quiz will be available through Canvas at the conclusion of scheduled online Saturday's class sessions. You will have until Wednesday at 11:59 PM Hawaii-Aleutian Standard Time (HSAT) to complete the Quiz. The quiz is to be placed in the appropriate drop box in Canvas. Any missed quiz will result in a grade of zero.

Exam

As indicated on the course schedule, there will be one midterm exam worth 100 points. The Exam is closed book/closed notes; however, students will be allowed to use one 8 ½ x 11 paper (front and back) as a "formula sheet" for the exam. The "formula sheet" must be hand-written (i.e., no pages typed {unless pre-approved by the professor}).

The exam will be 90-120 minutes in duration.

Final Exam

The final exam will be cumulative and will cover Topics 1 to 7. Students will have a week to complete the Final Exam, which will be distributed on Saturday December 2nd. These exams are due back for grading on Saturday December 9th by 2:30PM (HST). The final exam is worth 115 points.

In MBA 744 – Accounting Information for Strategic Decision Makers, we focus on the principle of "Provide an integral quality education." This means delivering a well-rounded experience where students not only learn key accounting concepts like Cost-Volume-Profit analysis, budgeting, and financial decision-making but also develop strategic thinking skills. The course integrates knowledge across business scenarios, preparing students for effective decision-making and leadership in a dynamic environment.

- 5. Educate for Adaptation and Change (Aina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203) All knowledge is not taught in the same school
