## **University Course Catalog Description and Overview**

This course is a continuation of PP7110 - Professionalization Group I taken in the Fall. These discussion groups for first-year students are led by a core faculty member. This course is designed to familiarize and assist students with their new roles as graduate students and future psychologists. Students discuss topics related to professional psychology and the development of a professional identity. The faculty leading the group helps students with academic and field training planning, general consultation on problems or difficulties in the program, and questions emerging during the student's first-year academic experience.

## **Marianist Values**

- 4. Educate for Service, Justice and Peace (Aloha) Ka lama kū o ka no'eau ('Ōlelo No'eau 1430) Education is the standing torch of wisdom
- 5. Educate for Adaptation and Change ('Āina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203) All knowledge is not taught in the same school

## **Program Learning Outcomes: HSPP Aims and Competencies**

The Hawai'i School of Professional Psychology at Chaminade University of Honolulu's clinical psychology doctoral program's aim is to educate and train students employing a practitioner-scholar model so that they will be able to function effectively as clinical psychologists. To ensure that students are adequately prepared, the curriculum is designed to provide for the meaningful integration of psychological science, theory, and clinical practice. The clinical psychology program at the Hawai'i School of Professional Psychology is designed to emphasize the development of knowledge, skills, and attitudes essential in the training of health service psychologists who are committed to the ethical provision of quality, evidence based services to diverse populations and who are able to apply multiple theoretical perspectives to clinical issues.

The Hawai'i School of Professional Psychology at Chaminade University of Honolulu's clinical psychology doctoral program subscribes to the American Psychological Association (APA) Standards of Accreditation. As such, students are expected to establish an identity in and orientation to health service psychology by acquiring the necessary discipline-specific knowledge and profession-wide competencies. Upon completion of the PSYD degree in clinical psychology, students will be able to:

- 1. Apply ethical and legal standards relevant to the practice of clinical psychology, including professional ethics that guide professional behavior.
- 2. Apply professional communication and interpersonal skills, to include the utilization of clear, informed, and well-integrated communication, as well as effective interpersonal skills across settings.
- 3. Apply professional values and attitudes across settings, including self-reflective practice and openness to supervision and feedback.
- 4. Apply awareness of individual and cultural diversity, including knowledge of theoretical models and diversity research that serve to guide the application of diversity competence.
- 5. Articulate and integrate the history and systems of psychology as well as the basic areas in scientific psychology, including affective, biological, cognitive, developmental, psychopharmacological, and sociocultural aspects of behavior.
- 6. Conduct science in psychology, applying psychometrics, statistical analyses, and quantitative and qualitative research methods.
- 7. Competently perform psychological assessments, including the ability to administer, interpret, integrate, and convey results of psychological tests.
- 8. Competently perform clinical interventions, including case formulation, theoretical conceptualization, developing and applying evidence-based treatment plans, and evaluating treatment effectiveness in work with clients.
- 9. Apply knowledge of consultation models and practices, including interprofessional and interdisciplinary skills in consultative services.
- 10. Articulate supervision models and practices, including areas of ethics and potential conflicts.
- 11. Apply the Marianist values, through acts of community service, justice, and peace.

## **Course Learning Outcomes**

1. Students will continue to develop communication and interpersonal skills through presentations and peer support activities (Competency 2).

- 2. Students will continue to develop awareness of diversity and ethical issues in clinical psychology through exploration of special settings in which psychologists serve and discussions. (Competency 4, 11)
- 3. Students will continue to develop basic awareness of professional, philosophical, ethical, theoretical, and empirical issues in clinical psychology, demonstrated in class discussions, literature review exercises, and presentations. (Competency 1)
- 4. Students will continue to develop their knowledge of the applications of a variety of roles taken on by professional psychologists, including knowledge of various theoretical orientations practiced; demonstrated in theoretical orientation presentations and discussions. (Competency 1 & 3)
- 5. Students will continue to develop self-reflection, self-management, and self-care skills to address academic, professional, and general life stressors, demonstrated in class discussions. (Competency 3)

## **Course Requirements**

Course Requirements in Relation to Credit Hours. This is a one-credit hour course requiring 45 clock hours of student engagement, per the official CUH Credit Hour Policy. Students enrolled in this doctoral-level course are anticipated to spend a minimum of 45 hours in class. The additional 90+ hours outside of classes are anticipated to equal 1-2 hours per week on course readings and class preparation, and 1-2 hours per week of work on future assignments (e.g., presentations, projects, papers, exams).

**Attendance/Participation:** Students are expected to attend every class, arrive on time, complete all assigned readings, exhibit professional and ethical behavior, and <u>actively participate</u> in class discussions. Unexcused absences, tardiness, unprofessional and/or unethical behavior, and/or lack of preparation/participation may result in a reduction of the overall score for the course or remediation as assigned by the instructor. Two or more unexcused absences may result in loss of credit for the course.

*Mock Interview:* In preparation for their practicum interviews, students will present professionally and respond appropriately in a 15-minute outside-of-class practice interview with the instructor.

**APA Publication Manual Modules:** These are self-paced, asynchronous course modules that students must successfully complete by the end of the term. For the Spring Pro Group course, students must successfully pass two modules: 1) Spelling, Capitalization, and Abbreviations, and 2) Works Cited in Text. You will be required to submit a screenshot of your passing module score.

Research Interest Presentation: Students will search the peer-reviewed literature for articles related to

a research topic/area of interest. This, for some, will be a preliminary step in developing a specific research question towards the dissertation requirement. Students will be required to submit a spreadsheet with at least 5 peer-reviewed studies related to a preferred topic of interest. The formatting of the spreadsheet will be discussed. The results will be shared in a 15-minute presentation. This presentation must culminate in a statement of a specific research question or questions that the review suggests are next step questions in the area of research you've chosen.

**Theoretical Orientation Presentation & Handout (TOP):** Students are to research a theoretical orientation, present their findings to the class, and lead a discussion about the orientation (30-minute presentation, 15-minute discussion). They will provide classmates and the instructor with a 2- to 3-page handout detailing the major points and mechanism of change of their chosen theoretical orientation.

OR

**Special Settings Paper & Presentation (SSP):** Students are to write a 2- to 3-page paper describing a special setting in which clinical psychologists may work, with appropriate citations. The paper must include; 1) the capacity in which psychologists serve in the setting; 2) the clients/patients/consumers served; 3) diversity in the populations served; and 4) ethical issues that can arise. Ideally, students that choose this assignment will do a site visit at such a setting or, at a minimum, interview a psychologist working in the special setting. The student will orally present their special settings paper to the class (20-minute presentation).

## **Grading Scale**

## **Minimum Competencies**

This course requires satisfactory completion of multiple graded requirements. Credit for the course will not be given until each requirement is successfully completed (i.e., a student cannot pass the course if any requirement does not meet minimum criteria).

## **Instructional Contact and Credit Hours**

The unit of semester credit is defined as university-level credit that is awarded for the completion of coursework. One credit hour reflects the amount of work represented in the intended learning outcomes and verified by evidence of student achievement for those learning outcomes. Each credit hour earned at Chaminade University should result in a minimum of 45 hours of engagement, regardless of varying credits, duration, modality, or degree level. This equates to one hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for approximately fifteen weeks for one semester. Terms that have alternative lengths, such as 10-week terms, should have an equivalent amount of faculty instruction and out-of-class student work to meet each credit hour. Direct instructor engagement and out-of-class work result in total student engagement time of 45 hours for one credit. The number of engagement hours may be higher, as needed to meet specific learning outcomes. The minimum 45 hours of engagement per credit hour can be satisfied in fully online, internship, or other specialized courses through several means, including (a) regular online instruction or interaction with the faculty member and fellow

students and (b) academic engagement through extensive reading, research, online discussion, online quizzes or exams; instruction, collaborative group work, internships, laboratory work, practica, studio work, and preparation of papers, presentations, or other forms of assessment. This policy is in accordance with federal regulations and regional accrediting agencies.

*Instructor and Student Communication:* Questions for this course can be emailed to the instructor. Online, inperson, and phone conferences can be arranged. Response time is up to 2 days.

## Assessment for Student Work:

With the goal of continuing to improve the quality of educational services offered to students, Chaminade University conducts assessments of student achievement of course, program, and institutional learning outcomes. Attendance Policy: Students are expected to attend regularly all courses for which they are registered. Therefore, using artificial intelligence (AI) and automated writing tools is *not permitted* for program submissions and will be considered academic dishonesty.

**Technology:** A laptop with the following technology may be required in order to complete courses in the Clinical Psychology program: at least Windows 10 (for PCs), at least Mac OS X 10.5.8 (for Macs); a current antivirus program; the current Microsoft Office (PowerPoint and Word) and Adobe Acrobat; a standard web browser; and an internet or broadband connection with speed and connectivity to support internet searches and video conferencing. Most courses are paperless, but a printer/scanner may also be required.
