Course Description & Materials

Catalog Course Description

Study of criminal behavior from a psychological perspective, looking at the criminal offender as embedded in and influenced by multiple systems within the psychosocial environment. Review of contemporary research, theory, and practice concerning the psychology of crime and psychopathy. Focuses on cognitive aspects of criminal offenders, delving into their perceptions, reasoning, beliefs, decision making, and attitudes. Aspects of prevention, intervention, and treatment are discussed along with topics such as profiling terrorism, criminology, and forensics.

Time Allocation

This is a three-credit hour course requiring 135 clock hours of student engagement, per the official CUH Credit Hour Policy. Over the 10 weeks of this course, students will spend 139 hours on course readings, ebook work, assignments, and discussions.

- 4. Describe and justify some of the special considerations related to the treatment of female, juvenile, and aging inmates.
- 5. Assess the various roles that a forensic psychologist may specialize in.

- 5. Educate for Adaptation and Change (Aina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203) All knowledge is not taught in the same school

Discussions

For discussions, you are expected to provide a substantive and thorough original post that demonstrates depth of thought, critical analysis, and a clear understanding of the topic. While there is no formal word count requirement, your response should fully address the prompt with well-developed ideas, supporting evidence where appropriate, and thoughtful reflection.

In addition to your original post (worth 10 points), you must also respond to at least two classmate's posts (worth 5 points each). Your response should go beyond agreement or simple comments—it should add to the conversation by offering additional insights, asking thoughtful questions, or respectfully challenging ideas to deepen the discussion. Discussions are weighted at 40% of the final grade.

Assignments

All written assignments should reflect substance, depth, and critical thinking. Your work must fully address all aspects of the prompt or assignment instructions, demonstrating a clear understanding of the material and an ability to apply, analyze, or evaluate relevant concepts. There is no strict word count (unless stated in the directions); instead, focus on thorough and well-developed responses that clearly convey your ideas.

Please ensure that all content is written in your own words. Direct quotes are not permitted. Instead, paraphrase information from your sources and properly cite them using APA formatting (7th edition). This includes in-text citations and a reference list at the end of your assignment. Be sure to proofread your work for clarity, grammar, and adherence to academic standards. Assignments are weighted at 40% of the final grade.

Final Paper:

A final research paper is required for this course. It shall contain an extensive explanation of the sub-specialties of a forensic psychology expert. For your final paper, you will address the five distinct roles that a forensic psychologist (FP) should have to attend to the sub-specialties within the discipline. Within each specialty, you should describe the role that the FP has, special considerations, legal issues, challenges, ethical considerations, etc. Feel free to elaborate on sections but make sure you cover the mandated content. The paper is worth 20% of your final grade.

- Below are the criteria for the paper:
 - Cover page
 - Abstract
 - Table of contents
 - Content pages (10 minimum)
 - Bibliography
 - The paper must be formatted via APA guidelines
 - NO QUOTES

A good rule of thumb is a minimum of one source/reference per paragraph. For a 10 page paper you should have no less than 15 sources. Remember, cite the original source. If you are going to discuss a court case then you should be citing the original case, not an author that has interpreted the case. Always use the original source.

** A rubric is used for grading assignments and discussions and will be provided to you in the announcement section of your Canvas course. It should be noted that the rubric will be used *ONLY* to grade the assignment given. You will not receive rubric credit for turning in a paper that has nothing to do with the assignment. For example: if you are given an assignment on police stress and you turn in a paper on how to change the oil in your car - you will not receive credit for grammar, spelling, etc. You will receive a zero as you did not complete the assignment.

Course Policies

Attendance

The field of Criminal Justice requires personal and professional dedication. It is also a profession that requires teamwork. There are no substitutions when a squad member calls in sick or chooses not to come to work. This class shall be conducted to imitate "real world" experiences thus, *attendance is mandatory*. Failure to attend class will be reflected in your final grade. It's very simple, you are either there to participate or you are not. Medical documentation for a missed class does not apply. Participation requires you to be in class so if you miss a class you do not receive the points. It is also important to note that I will not teach this class twice. If you miss a class it is up to you to meet with a classmate to obtain notes or other information you missed. Do not ask me what you missed in class! Additionally, participation in classroom discussions is expected. This can only be accomplished if you have read and understood the material prior to class. Participation is worth 5% of your grade.

- o It should be noted. Attendance in Canvas will be taken accordingly:
 - Green attended class on time and prepared for class. Participated in the discussion.
 - Yellow attended class late and/or on time unprepared with little to no participation.
 - Red did not attend class and/or attended class unprepared with no participation.

Late Work

Since all assignments/discussions are open on the first day of class it is recommended that students work ahead if/when possible if they anticipate a late submission. The ONLY exception to this policy is a catastrophic emergency (at my discretion, not the students).

Whatever the last submission is PRIOR to the due date and time is the one I will grade. I will not grade a resubmission after the due date.

If you do so, please add a comment to the instructor that you intend to re-submit the assignment so it is not graded until you are satisfied with the similarity score. If you notice that there are a lot of similarities in the reference section, please disregard. If you are doing those correctly, they should match with other work. Any instances of plagiarism will be subject to discipline (see below section on academic honesty).

ARTIFICIAL INTELLIGENCE CHECKER:

This course prohibits the use of AI software in completing any assignments, projects, or exams. The use of AI software is defined as the use of any computer program or algorithm that utilizes machine learning, natural language processing, or any other form of artificial intelligence to assist in completing coursework.
