## Course Description & Materials

## **Catalog Course Description**

FS 340 Crime Scene Investigation (3)

Introduction to techniques of crime scene investigation. Emphasis will be on search techniques, scene diagramming, photography, proper documentation, recover and preservation of different categories of evidence. Aspects of chain of custody of materials collected and other problems related to admissibility of evidence will be discussed.

*Pre-Requisites:* EN-102, COM-101, FS-233L or FS-333L with a grade of "C" or better.

**Co-requisite:** FS-340L with a grade of "C" or better.

#### **Time Allocation**

This is a three-credit-hour course requiring 135 clock hours of students' engagement per the official CUH Credit Hour Policy. Students enrolled in this course are anticipated to spend 37.5 hours in class, 28 hours researching and preparing the presentation for the final oral exam, 16 hours studying for the midterm exams, and 10.5 hours studying for and taking the final exam. There will be an additional 43 hours of work required beyond what is listed here (course reading, homework assignments, etc.), averaging 2.9 hours each week.

This class requires a textbook that will be complemented by lectures. The lectures are based on the textbook chapters, with some additional materials included in the recommended textbooks. My advice is to read the book chapters and listen to the lectures.

- 1. Define the role of forensic science in criminal investigation.
- 2. Identify physical evidence and the information it can provide.
- 3. Describe quality assurance strategies in the forensic sciences, including the legal system, accreditation, and certification.
- 4. Describe acceptable professional conduct in the forensic sciences.

- 5. Educate for Adaptation and Change (Aina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203) All knowledge is not taught in the same school

## **Evaluation of Student Performance**

## **Evaluations (980 Total points)**

## -Attendance: (430 points)

Classes are scheduled to meet in person every Monday, Wednesday, and Friday unless indicated otherwise. You will earn ten points per class attended starting Monday, 25 August. Please be aware that the total attendance points will change if a class period is cancelled due to illness, weather, or another reason.

## -<u>Participation</u>: (50 points)

This course considers participation points. You will earn 50 points during the semester once you participate in classes. This participation can be commenting on or discussing some topic, case, opinion, questions, among others, expressed during the lecture time.

If you miss an exam and your absence is considered unexcused, you will be given a 0 point for attendance *and* for the exam.

- Exams and Individual case presentation: (500 Points Total)
  - This course includes two midterm exams, one individual case presentation, and one final oral exam.
  - The two midterm exams will consist of multiple-choice questions and short essay responses and are worth **100 points each**.
  - The individual case presentation is worth **100 points** and will be assessed using a rubric specifically designed for it. Professional attire will be considered in your grade.
  - The final oral exam will consist of one question based on the previous midterm exam and the knowledge you have gained during this course. This final exam is worth **200 points**.

Unexcused missed exams will receive a grade of 0 points.

#### **Extra Credit**

If any student needs an extra credit assignment, they should approach the instructor at least one month before finals week (December 8<sup>th</sup> to the 11<sup>th</sup>) to discuss possible options. It won't be an extra credit assignment for unexcused absences or other situations where students have shown a lack of interest in the course.

#### Lateness:
