### **Course Description & Materials**

### **Catalog Course Description**

This course provides an overview of microeconomics and macroeconomics and introduces the economic way of thinking to non-business major students. Special emphasis is given to understanding how economic concepts influence individuals' and organizations' daily choices. This course fosters the understanding and applying economic tools and core reasoning that underlies critical thinking, decision-making, and problem-solving to various personal, organizational, and social issues.

#### **Time Allocation**

This is a three-credit hour course requiring 135 clock hours of student engagement, per the official CUH Credit Hour Policy. Over the 15 weeks of this course, students will spend 45 hours in class, 30 hours working on assignments, 15 hours working on exercises, 10 hours studying for weekly quizzes, and 12 hours studying for and taking three exams. There will be an additional 3 hours of work required beyond what is listed here (course readings, homework assignments, etc.), averaging 2.2 hours each week.

- 4. Educate for Service, Justice and Peace (Aloha) Ka lama kū o ka noʻeau ('Ōlelo Noʻeau 1430) Education is the standing torch of wisdom.
- 5. Educate for Adaptation and Change (Aina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203) All knowledge is not taught in the same school

### **Course Activities**

#### **Assessment**

Late penalty for exam is 10 points deduction per day.

#### **Challenging a Grade on an Individual Assignment**

Should a student find at any point during the semester that they wish to challenge a grade they have received on an

- Students must wait 48 hours after receipt of their assignment before challenging the grade
- Grade challenges must be submitted in writing via email, in respectful and professional prose
- Students must articulate, based on the merits of their work (not on circumstances) and the guidelines of the assignment/rubric, why they feel their grade should be amended
- Students have up to 2 weeks to challenge an assignment grade if desired.
