## Course Description & Materials

### Catalog Course Description

Every business speaks a language—and accounting is where that language begins. In this course, students learn how financial data becomes the backbone of strategy, insight, and action. From recording real-world transactions to preparing key financial statements, students will see how numbers are more than numbers—they are tools for influence, forecasting, and smart decision-making. This course connects financial and strategic accounting in a way that feels relevant, modern, and alive. Students will explore how financial information supports internal analysis, operational planning, and ethical thinking. Along the way, we introduce the emerging role of AI and technology in transforming how data is interpreted and used to drive results. Whether you're headed into finance, management, entrepreneurship, or tech-driven accounting, this course lays the foundation for how great decisions are made.

*Prerequisite: English 102 and Communication 101 are prerequisites for all upper division courses.*

### Time Allocation

The unit of semester credit is defined as university-level credit that is awarded for the completion of coursework. One credit hour reflects the amount of work represented in the intended learning outcomes and verified by evidence of student achievement for those learning outcomes. Each credit hour earned at Chaminade University should result in a minimum of 45 hours of

engagement, regardless of varying credits, duration, modality, or degree level. This equates to one hour of classroom or direct faculty instruction and a minimum of two hours of out-of-class student work each week for approximately fifteen weeks for one semester. Terms that have alternative lengths, such as 10 week terms, should have an equivalent amount of faculty instruction and out-of-class student work to meet each credit hour. Direct instructor engagement and out-of-class work result in total student engagement time of 45 hours for one credit. The number of engagement hours may be higher, as needed to meet specific learning outcomes.

This course is intended to provide students with the accounting knowledge necessary to understand and use financial information in the world of business. Emphasis is placed on understanding accounting terminology and concepts and their practical application to managerial and organizational decision-making. Accounting is a rigorous subject area; consequently, students will be expected to devote a significant amount of time outside of the classroom throughout the term. **This is a three credit hour course requiring 135 clock hours of student engagement, per the official CUH Credit Hour Policy. Students enrolled in this course are expected to spend about 40.66 in class, 3 hours writing response cases/projects, 10 hours studying for the midterm exam, 24 hours revising course cases/projects, and 10 hours studying for the final exam. There will be an additional 47.34 hours of work required beyond what is listed here (course readings, homework assignments, etc.). This additional work will average about 3 hours per week.**

### Marianist Values

This class represents one component of your education at Chaminade University of Honolulu. An education in the Marianist Tradition is marked by five principles and you should take every opportunity possible to reflect upon the role of these characteristics in your education and development:

This course directly reflects the Marianist values of **providing an integral, quality education** and **educating for adaptation and change** by positioning accounting as an integrated system for understanding, evaluating, and guiding business decisions. Students engage with the full accounting cycle and apply financial information in realistic organizational contexts, emphasizing how accounting data supports ethical judgment, responsible stewardship, and informed decision-making.

Through applied case-based learning and structured analysis, students develop the ability to interpret financial statements, evaluate alternatives under policy and resource constraints, and consider the broader implications of financial decisions on organizations and communities. The course further emphasizes adaptation and change by introducing students to emerging considerations in sustainability, governance, and technology-enabled analysis, preparing them to respond thoughtfully to evolving business environments. This approach encourages disciplined thinking, ethical awareness, and lifelong learning consistent with the Marianist tradition and the demands of modern business practice.

### **Native Hawaiian Values**

Education is an integral value in both Marianist and Native Hawaiian culture. Both recognize the transformative effect of a well-rounded, value-centered education on society, particularly in seeking justice for the marginalized, the forgotten, and the oppressed, always with an eye toward God (Ke Akua). This is reflected in the ‘Olelo No’eau (Hawaiian proverbs) and Marianist core beliefs:

1. Educate for Formation in Faith (Mana) E ola au i ke akua (‘Olelo No’eau 364) May I live by God.
2. Provide an Integral, Quality Education (Na’auao) Lawe i ka ma’alea a kū’ono’ono (‘Olelo No’eau 1957) Acquire skill and make it deep.
3. Educate in Family Spirit (‘Ohana) ‘Ike aku, ‘ike mai, kōkua aku kōkua mai; pela iho la ka nohana ‘ohana (‘Olelo No’eau 1200) Recognize others, be recognized, help others, be helped; such is a family relationship.
4. Educate for Service, Justice and Peace (Aloha) Ka lama kū o ka no’eau (‘Olelo No’eau 1430) Education is the standing torch of wisdom.
5. Educate for Adaptation and Change (Aina) ‘A’ohe pau ka ‘ike i ka hālau ho’okahi (‘Olelo No’eau 203) All knowledge is not taught in the same school

## Course Activities

### Attendance Grading Policy

Attendance is an important part of your success in this class. Beginning January 16, 2024, **10% of your overall course grade** will be based on attendance.

- Each student is allowed up to **two (2) unexcused absences** without penalty.
- Absences excused by a doctor's note, official documentation, or an athletics absentee schedule will not count against you.
- Starting with the **third unexcused absence**, you will lose **2.5% of the attendance grade** (out of the total 10%) for each additional class missed.
- Once you reach a total of **six (6) unexcused absences** (including the first two free ones), you will have lost the entire **10% attendance grade**. At that point, the highest overall course grade possible will be **90%**.

This structure rewards consistent participation while recognizing legitimate reasons for missing class.

### Homework

The assignments as indicated on the Course Schedule are to be turned-in the class period following the assigned date. All homework assignments are to be turned in through canvas using either an excel spreadsheet, word document or pdf file of handwritten homework. Late homework will be discounted accordingly. Each homework assignment is worth 10 points.

### **Signature Case Analysis**

This course includes a required **Signature Case Analysis** designed to integrate accounting mechanics with financial interpretation, ethical reasoning, and values-based decision-making. Working in small groups of **two to three students**, participants will assume the role of organizational management and apply the accounting cycle to a comprehensive case provided by the instructor.

As part of the Signature Case, student groups will prepare and analyze financial information beginning with an opening balance sheet and progressing through transaction analysis, adjustments, and the preparation of financial statements. In addition to completing the accounting cycle, students will evaluate key financial measures, assess constraints and trade-offs, and develop a reasoned recommendation supported by quantitative evidence.

The Signature Case is intentionally structured to address the Program Learning Outcomes for which AC-204 is responsible. **PLO-2 (Quantitative Reasoning)** is addressed through financial analysis and interpretation of accounting data; **PLO-4 (Ethics)** is addressed through evaluation of professional responsibilities and the ethical implications of financial decisions; and **PLO-7 (Marianist Values)** is addressed through consideration of stewardship, sustainability, and responsible organizational decision-making. The case culminates in a professional, management-level communication that clearly articulates the financial and ethical basis for the group's recommendation.

Use of analytical and generative tools, including ChatGPT, may be permitted as support for organizing information or clarifying concepts; however, all calculations, interpretations, and final judgments must reflect the independent work and understanding of the student group.

## **Quizzes**

There will be one quiz during the course worth 25 points. The quiz will cover materials from the chapters discussed during our regular class sessions. Quizzes cannot be made up; any missed quiz, regardless of the reason for the absence, will result in a grade of zero. All quizzes will be available through Canvas on the evening of the scheduled class session. You will have from the evening on the day of the class session until 11:59 PM Hawaii-Aleutian Standard Time (HSAT) the designated due date to complete the Quiz (i.e. quizzes are typically due on the evening of the following day of issuance), which is to be placed in the appropriate drop box in Canvas. The timing of Quizzes may be adjusted as the necessity arises to do so. Again, any missed quiz will result in a grade of a zero.

## **Midterm Exams**

As indicated on the course schedule, there will be one midterm exams worth 100 points. Students will lose 5% from your raw score for each day exams are past due up until the date the professor reviews the exam. Student who have not completed their exams prior to the professor's review will receive an automatic zero for that exam.

## **Final Exam**

The Final Exam will be distributed on Wednesday April 22<sup>nd</sup> 2026. The exam is cumulative and covers all modules. The completed exam should be uploaded into the AC-201 Class Canvas site for grading no later than Wednesday April 29<sup>th</sup> 2026 at 12:10pm
