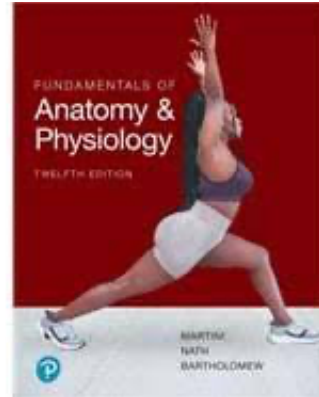

Course Instructions and Credit Hour Policy

This is a three-credit hour course requiring 135 clock hours of student engagement, per the official CUH credit hour policy. Students enrolled in this course are anticipated to spend 37.5 hours in class, 10 hours studying for and taking each of 5 exams (50), and 20 hours studying for and taking the final exam. There will be an additional 27.5 hours of work required above what is listed here, to include but not limited to, course readings, classroom discussions, and homework/writing assignments.

Course Overview

Human Anatomy and Physiology I (BI 151) is an introduction to the human anatomy and physiological systems. Necessary life functions and survival needs will be examined, followed by an orientation of the language of anatomy. Thorough analyses of intracellular function, tissue types, the integumentary system, skeletal tissue and the human skeleton, joints, muscle tissue and the muscular system, the fundamentals of nervous tissue, the nervous system, and the endocrine system will follow. Required course for nursing majors. Non-nursing students (e.g. pre-health professions students) may take this course subject to availability of seats in a separate course section than nursing majors. Co-requisites: BI 151L, NUR majors.

Marianist and Native Hawaiian Values

Education is an integral value in both Marianist and Native Hawaiian culture. 3. Educate in Family Spirit ('Ohana) 'Ike aku, 'ike mai, kōkua aku kōkua mai; pela iho la ka nohana 'ohana. ('Ōlelo No'eau 1200) Recognize others, be recognized, help others, be helped; such is a family relationship.
4. Educate for Service, Justice and Peace (Aloha) Ka lama kū o ka no'eau ('Ōlelo No'eau 1430) Education is the standing torch of wisdom.
5. Educate for Adaptation and Change (Aina) 'A'ohe pau ka 'ike i ka hālau ho'okahi ('Ōlelo No'eau 203). All knowledge is not taught in the same school.

Course Learning Outcomes

1. Create graphs depicting selected anatomical or physiological data.
2. Describe the scientific method and apply it to the study of human anatomy and physiology.
3. Demonstrate practical knowledge of human gross and microscopic anatomy.
4. Define and correctly use anatomical terminology to explain the physiology of the major organ systems.
5. Identify structures in the body and analyze their relationship with other body structures.
6. Explain the processes involved with maintaining homeostasis and anticipate what may occur when homeostatic balance mechanisms are lost.
7. Describe disease states, both genetic and acquired etiologies, and their current medical treatments.

1. Explain fundamental biological concepts and their interrelationships across various levels of biological organization, from molecules to ecosystems, including cell biology, genetics, evolution, physiology, and ecology.

3. Design and conduct scientific investigations using advanced methodologies, technologies, and resources, and communicate results effectively to professional and lay audiences.

5. Analyze societal challenges related to health and the environment through the lens of biological science, recognizing how biological knowledge and associated career paths can contribute to studying, addressing and solving these challenges.

Grades will reflect an overall understanding of topics covered during the course. Attendance, completion of assigned readings, and attentiveness in the lecture will ensure satisfactory performance in the class. Demonstrating a thorough understanding of course material and intelligent engagement in class discussions constitutes high achievement in the course. We will have in-class work to do to facilitate class discussion, which may range from group activities, reviews of current literature, media, articles, and class discussions. Group activities may consist of brief oral reports or short written reports. For written coursework, you will be graded on your ability not only to answer the question, but also in how effectively you can defend your answer/position using your knowledge of the subject & applying what you learned using appropriate facts and examples.

Grading Scale

Letter grades are given in all courses except those conducted on a credit/no credit basis. Grades are calculated from the student's daily work, class participation, tests, reports and examinations. They are interpreted as follows:

- A (90% & above) Outstanding scholarship and an unusual degree of intellectual initiative
B (80–89%) Superior work done in a consistent and intellectual manner
C (70–79%) Average grade indicating a competent grasp of subject matter
D (60–69%) Inferior work of the lowest passing grade, not satisfactory for fulfillment of course
F (59% & below) Failed to grasp the minimum subject matter; no credit given

It is the instructor's prerogative to modify deadlines of course requirements accordingly. Any student who stops attending a course without officially withdrawing may receive a failing grade. Unexcused absences equivalent to more than a week of classes may lead to a grade reduction for the course. Any unexcused absence of two consecutive weeks or more may result in being withdrawn from the course by the instructor, although the instructor is not required to withdraw students in that scenario. Repeated absences put students at risk of failing grades.

Federal regulations require continued attendance for continuing payment of financial aid. AI (Artificial Intelligence) Statement

Chaminade University recognizes the increasing role of artificial intelligence (AI) technologies in academic and professional environments. AI encompasses, but is not limited to, generative AI platforms, automated writing or content generation software, coding assistants, and similar tools. Students must ensure all submitted work genuinely reflects their knowledge and effort. Using AI to produce or significantly complete graded assignments, exams or other academic tasks – defined as use that substitutes for or substantially replaces a student’s own analysis, reasoning or written expression – without explicit instructor approval is considered academic misconduct and will be dealt with according to the University’s Academic Honesty Policy. If an instructor has reasonable grounds to question whether submitted work genuinely reflects a student’s own knowledge, authorship, or mastery of course material — or whether it meets the course’s expectations for AI use — the instructor may require the student to provide additional or alternative evidence of authorship and content mastery. Such evidence may include drafts, notes, revision history, source materials, process explanations, oral discussion, in class work, or completion of an alternative assessment. A student’s refusal or inability to provide such evidence may be considered, along with other available information, in evaluating whether the work meets course requirements and stated learning outcomes. Instructors will not rely solely on AI detection software or other automated tools in making grading or academic integrity determinations. Such determinations will be based on the totality of the available information and handled in accordance with applicable University policies and procedures. - Complete or partial copying directly from a published or unpublished source without proper acknowledgement to the author. Minor changes in wording or syntax are not sufficient to avoid charges of plagiarism. Proper acknowledgement of the source of a text is always mandatory.
- Paraphrasing the work of another without proper author acknowledgement.
- Submitting as one's own original work, however freely given or purchased, the original exam, research paper, manuscript, report, computer file, or other assignment that has been prepared by another individual.
- Use of generative artificial intelligence (AI) without permission by instructor. Sentences, paragraphs, or entire papers written by AI are not original work.
