- 1. Discuss how the "red scare" after WWI effected the American psyche and give examples of how that short-lived phenomenon was perpetuated within American culture.
- 2. At the end of the 19th century America became a world power. Discuss the factors that drive America into the realm of imperialism. What were the arguments for this expansionist attitude and were the arguments against such policy?
- 3. What does the text define as the "Gilded Age?" What marks this portion of American history aside from those that came before it? Specifically discuss the changing nature of politics during this period.
- 4. Discuss the Freedmen's Bureau. What were its goals, and how effective was it at accomplishing these goals?
