<u>ORGANIZATION</u>: This course will run for 10 weeks as outlined below. Classes—on Fridaymeet from 5:30 p.m. to 9:40 p.m. Course format is lecture/discussion, but several videos will be shown and there may be a guest speaker and/or a field trip.

GRADES: Your final grade in the course will be based upon your attendance, participation and performance on the examinations and course paper. There will be two examinations, a Mid-Term and a Final, and one Course Paper, of moderate length. The Mid-Term examination will cover about half of the book, up through Chapter VII, and the Final will cover the rest of the text. Attendance, the exams and paper will each count for 25%. However, should your Final Exam and Course Paper show considerable improvement over your earlier effort, they will be given greater significance. Each exam will consist of objective and essay questions.

COURSE PAPER: The nature and content of the Course Paper will be discussed in class.
