### Course Description:

An overview of sexual deviation in American society; legal definitions and sanctions for sexually deviant behavior; victims of sexual abuse; sexual abuse of children and child protective systems; treatment of sexual offenders; sexual serial murderers.

### Course Objective:

Upon completing this course, the student should be technically knowledgeable about sexual crimes, sexual offenders, victims of sexual abuse, and the systems which respond to these crimes, offenders, and victims.

### Course Format:

This course will consist of three basic components:

1) Readings of required texts, and material on library reserve shelf (readings must be completed

by the date scheduled on this course outline).

2) Lectures and in class dialogue

3) Student research

\*) Guest speakers, depending upon availability.

### Attendance and Participation:

Regular class attendance and participation is required to pass this course. Two (2) excused absences are allowed. All absences must be supported by a valid excuse acceptable to the Dean. Bring two copies of your synopsis to class (typewritten) and two copies of the article (turn in one copy of each at the end of class).

The article can be from a scholarly journal or other publication in the area of Criminal Justice, Criminology, Social Work, Psychology, Sociology, Law, Medicine, or related fields. You can research these topics at the UH Libraries or on the internet at sites like the Criminal Justice Periodicals Index. Sullivan Library has an information sheet on computer research for your use.

In class, we will discuss the articles. Use your synopsis to remind you of the main points of the article, and to allow me to review your understanding of the article. You will receive full credit for the assignment if you turn in an article, a synopsis, and present ideas about the article in class.

### Assignment due 9/23:

Research rape relief/counseling agencies on the Island of Oahu.

Write your research up as resource sheets that you could use if you were a Police Officer or a Social Worker and needed to know what agencies were in your community. A good format for this assignment would be:

Agency name, address, phone, hours of operation, public or private agency (?), contact person, services provided, fees (and if a sliding scale is available for low income clients), populations served, and any other useful information. Make one sheet per agency. \*\*\*Note that you may find agencies that specifically provide services to victims of sexual assault, and others that provide services in a variety of situations including sexual assault. Note these aspects in the "services provided" section of each sheet.

You may team up with other students in class to complete this work. If you do, be sure to include each of your names on the materials. Make an effort to find at least two agencies in our community that provide assistance to victims of sexual assault. You can find this information by searching out agencies in the phone book and on the internet. Then, call them up and ask to speak with someone that can give you general information about the agency. You can also call social service agencies and ask about other agencies that they may know of. If you get stuck, call me and I will give you some ideas of how to start a search. This is the type of real world research you will do as a police officer, social worker, or even as a prosecutor. The idea here is that you need to be ready to offer resources to victims of sexual assault as soon as help is requested.
