Case Project:

Each student will write a case project paper that includes the following criteria:

- APA or MLA format, 1000 1250 words
- Assigned cases from the textbook with additional research included.
- Must include at least 3 outside references in addition to the textbook
- Use of in-text citations as appropriate
- Outline of cases:
  - a. Abstract of case (half page)
  - b. Identification of the main problem(s) (half page)
  - c. Identification of ethical/moral theoretical basis for problem identification and resolution (half page)
  - d. Description of the alternatives for problem resolution (one page)
  - e. Recommendations (one page)
  - f. List of references/cited works (half page)

Grading criteria for the Course Project

- 80% of final grade based on content and evidence of applied learning and use of critical thinking skill
- 20% of final grade based on use of appropriate format, citations, and outside references.
- Students need to submit their final case project on or before October 4, 2002. Papers submitted late will receive a 20% reduction in the final grade for the paper.

Classroom Policies:
