Participation: Students will be evaluated on their participation in class by replying a half page in length feedback to at least one other student per week per discussion question.

Administrator/Director Interview: Students will individually vist an early childhood education site and create/conduct their own two page interview with an Administrator/Director. The interview should include the Administrator's/Director's roles and routines.

Head Teacher Observation: Students will observe a Head Teacher of an early childhood education school or site. The roles and routines of the Head Teacher will be discussed. Guidelines of this observation is located in the "course contents" folder on the main page of Web CT. *Please make sure to follow the format when writing your observation paper. This format is located in the course contents section. Click on course contents icon and you will find the format.*

Weekly Discussion Questions: Each week there will be a discussion question posted. Please make sure to write a one page response to the question.

Final Paper: The final paper will be on a topic chosen by the student that has to relate with a current issue or trend in early childhood education. You may use your text by Jalongo as a guide. If you wish to make a new topic, please submit your request to me before you write your paper. The paper must be 3-5 pages in length APA writing style.
